## DEPOSIT REQUIREMENTS

Please remit a deposit of 200 euros per 100 square feet (9.3 square meters).

No application will be processed without the required deposit amount. Deposits are non-refundable unless Phuket Art Fair 2026 declines the application.

No foreign checks will be accepted.

## APPLICATION AGREEMENT

1. This Exhibitor Application and Contract (this "Agreement"), completed in its entirety and accompanied by the requested information and materials, constitutes an application for exhibit space in Phuket Art Fair 2026. It is subject to review and approval by Phuket Art Fair 2026. All applications will be accepted or declined at the sole discretion of Phuket Art Fair 2026.
2. Accepted applications will be approved via La Fabrique OÜ's formal approval letter after the selection process and dated by La Fabrique OÜ's to become a binding contract. Applications that are not accepted will be refunded the full deposit less the application fee of 400 euros.
3. All exhibitors agree to be bound unconditionally by the La Fabrique OÜ Terms and Conditions (available on the website [www.phuketartfair.com](http://www.phuketartfair.com)).
4. If accepted, the balance of the booth cost shall be paid by Exhibitor in accordance with the assigned payment schedule and no later than 50% by October 30th, 2025 and the remaining balance by March 1st, 2026. In the event Exhibitor fails to make such payments on schedule, La Fabrique OÜ reserves the right to reassign Exhibitor's booth location and/or offer said booth location to other Exhibitors. Exhibitor shall remain fully responsible and liable for any and all obligations as set forth in this Agreement.
